Ball Brothers Foundation: Emphasizing family and community

These three adjectives guide the funding decisions of the Muncie-based Ball Brothers Foundation, according to Program Officer Jenna Wachtmann.

Both Wachtmann and Senior Program Officer Rich Spisak, who came to the foundation just over a decade ago as its first full-time officer, took time recently to share the vision, innovations and unique focuses of the foundation, which at age 90, is among the earliest established foundations in the country.

"Part of the role of this foundation is it is able to provide efficient, flexible and patient capital. I think patient capital is a really good term for the work that we do. We can be patient and see things through," Wachtmann said. [Read more.](#)



Optimus Primary overview

Over the course of the past two years, Ball Brothers Foundation has been working on a series of concepts with representatives from IUH Ball Memorial Hospital (Jeff Bird, M.D.) and the IU School of Medicine (Derron Bishop, Ph.D.).

It has been discussing opportunities to enhance one of the state's largest physician training programs outside of Indianapolis. Muncie is excellent at preparing both medical education students and medical residents for careers in medicine, but we believe that even more can be done. It believes even better opportunities can be developed around our entire continuum of healthcare services.

Through these conversations, several ideas have been identified to help recruit the best future doctors to train right here in Muncie and to make Muncie a top choice for medical students and medical residents. On a larger scale, these ideas have powerful potential to strengthen the broader pipeline of medical professionals being trained in Indiana and to make a significant economic development impact. Dubbed "Optimus Primary, this concept focuses on enhancing Muncie's four-year medical school program, the residency program and building a strong team culture within the local healthcare cluster.

Culture and technology

With our workplaces more technology-driven than ever, the decisions that managers and executives make regarding a nonprofit's investments on technology are difficult. How much, how new, how efficient?

More and more, however, nuanced decisions are needed around technology's impact on the culture and stress level of staff members.

Consider the following questions:

Does your staff have adequate tools to do their jobs?

Do we expect builders to reuse old nails or a hammer with a broken handle?

When staff members waste large blocks of time waiting for software to load, using work arounds for hardware that doesn't function or routinely lose work because of glitchy tech - it's hard for them to feel good about the workday.

Solution: Develop an equipment life-cycle plan. Document your equipment deployment dates and warranty information, and then plan for (and budget for) replacing equipment as it reaches its end of life. [Read more.](#)
