Facebook Live streaming spotlights ethical, legal policies

A live, 10-minute video of the aftermath of a police officer shooting a black man in Minnesota was the latest example of the riveting power of video streaming and the complex ethical and policy issues it raises for Facebook Live and similar features.

Facebook this year has made its Live feature, which allows anyone to broadcast a video directly from their smartphone, a central component of its growth strategy. Rivals Twitter and Alphabet's YouTube are also pushing live video as a new frontier in Internet content.

While traditional TV broadcasters are subject to "decency" standards overseen by the Federal Communications Commission -- and have a short delay in their broadcasts to allow them to cut away from violent or obscene images -- Internet streaming services have no such limitations.

That easy accessibility and openness are fostering a new type of intimate, personal broadcasting that proponents said can be extraordinarily powerful, as evidenced by the demonstrations that began shortly after the Minneapolis video. [Read more.](#)





Social unrest tests and pushes new boundaries for media, tech

Last month was a difficult one. As a society we struggled to make sense of one senseless act after another. The bandage we have had covering our mistrust, our anger and our frustration got yanked off, revealing that even after more than 150 years the scab remains, the wound can still bleed.

Unlike social unrest of the past, we didn't read about it in the next day's newspaper or watch carefully edited 30-second clips on the nightly news. No, we lived it. We sat in the front seat of the car and watched Philando Castile die; and on the streets of Dallas as a sniper took down one officer after another, finally dying in a robot's suicide mission.

And just as social media gave us an unrelenting view of the violence, it also inspired us to act. Around the country, including Greenville, people were brought together because they saw a post on Facebook or Twitter. [Read more.](#)



New social media tools empower citizen journalism

It may be inside a protest rally, or in front of a deadly shooting. Smartphones, video and social media are empowering citizens to tell their stories like never before.

This became clear with the live video earlier this summer from Diamond Reynolds when she captured the aftermath of the shooting by a police officer of her boyfriend Philando Castile in Minnesota and streamed it live on Facebook.

The unprecedented live feed was just the latest in a series of events highlighting the power of citizen journalists to bring to light events and viewpoints that would otherwise not be part of mainstream media.

Citizen journalism has been around for centuries, but each technological advance has made it easier to reach more people, said Valerie Belair-Gagnon, who heads the Yale University Information Society Project and is an incoming professor of journalism at the University of Minnesota. [Read more.](#)

Common audit pitfalls and misperceptions

While not required by Indiana law, one reason a nonprofit might conduct an audit is to demonstrate the organization's commitment to financial transparency and accountability.

And while a nonprofit can spend considerable resources for its annual audit, it is important that it consider the following to ensure the audit is a success.

No delays: An audit needs to avoid any major delays. It is important that an auditor schedule



significant time to complete most of the audit during fieldwork. The nonprofit needs to prepare for the auditor and have all the major items ready prior to the start of the audit. An auditor and the nonprofit should work together to complete any open-audit items prior to the audit.

Minimal accrual and year-end adjustments: The nonprofit needs to ensure that all accrual and year-end adjustments are completed prior to the start of the audit and to verify that last year's audit adjustments have been recorded and reconciled with the prior audit. It is also important to understand and record any adjustment so that auditor is not performing the nonprofit's responsibilities. [Read more.](#)


