# Groundwork Indy: Developing a neighborhood and youth

Most teenagers don't sit around talking about invasive plants and medicinal herbs or brownfields. But at least a half dozen area teenagers are the exception. Isaac, 15, Adarin, 16, Nashawn, 16, Randie, 16, Aliza, 15, and De'Shawn, 19, spend Saturday mornings researching and learning more about these topics, while also getting their hands dirty.

These six teens are members of Groundwork Indy's Green Team, and spend not only their Saturdays during the school year, but summers too, learning how to best help the Northwest Area neighborhood. Not all live in the neighborhood now, but several were born there. The area is bounded roughly by 16th Street on the south, 38th Street on the north, Martin Luther King Street on the east and Kessler Boulevard North Drive on the west.

Their work stems from an extensive community assessment. First, there was a feasibility study by a steering committee to determine if Indianapolis was a right place for a Groundwork program, and at the same time a Northwest Area Quality of Life plan was being developed. With 40 percent of the homes vacant, 584 of the 3,840 acres dedicated to green space lacking attention, and multiple identified brownfields, there is plenty of work to go around. [Read more.](#)



## Groundwork Indy's roots

In the 1980s, Liverpool, England started an experiment. Working with young people, the program improved areas that had been neglected. After success, Groundwork UK was established by Prime Minister Margaret Thatcher to promote local partnerships that could rebuild Britain's bypassed urban communities through community-led strategies.

It's success lead the U.S. National Park Service staff to travel to the U.K. to learn more. Impressed, the National Park Service launched the Groundwork USA in 1996, recognizing its potential to build upon the human and environmental assets found in every community. [Read more.](#)



## Northwest Area: Progress and redevelopment plan

The Northwest Area (NWA) is a culturally rich but economically distressed coalition of neighborhoods located 2 miles northwest of Indianapolis' vibrant Downtown.

This plan, created through the U.S. EPA Brownfield Program's Area Wide Planning process, emerged as a vehicle to tap the opportunity, which exists among the many brownfield sites found in the NWA. Specifically, the former Carrier-Bryant site is a significant, near-term opportunity for brownfield redevelopment, primed to drive beneficial and transformative change in the Northwest Area. The City of Indianapolis and its partners, recognize the potential for this 19-acre site to catalyze the revitalization of the surrounding community. [Read more.](#)

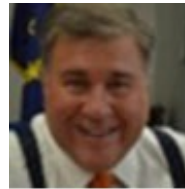

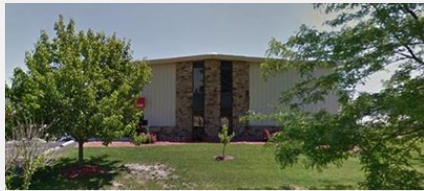
