Indiana Statehouse mid-session

Last week marked the last committee meetings of the first half of the session, as both chambers scramble to wrap up any bills they want to move forward into the second half of the session. Tuesday was the last day both chambers can approve a bill if they want it to move forward. The legislature will then take the rest of the week off and return the following Monday, March 6.

'Prayer in school' bill gains support

A bill preventing discrimination of students expressing religious beliefs in school passed out of a committee this week and goes to the full House floor for a full vote.

If made into law, schools would have to provide opportunity for students to express their own religious beliefs during events where other students are speaking. The Department of Education and state attorney would be required to provide a "model policy" on these issues for schools to adopt. [Read more.](#)





Q&As: The Johnson Amendment

In his address to the National Prayer Breakfast, President Trump vowed to "get rid of and totally destroy the Johnson Amendment and allow our representatives of faith to speak freely and without fear of retribution."

Some conservative Christian groups will welcome the promise, but many Americans may wonder what Trump was talking about. Here are five basic questions that we can answer.

1. What is the Johnson Amendment?

The Johnson Amendment regulates what tax-exempt organizations such as churches can do in the political arena.

Under terms of the 1954 legislation (named for its principal sponsor, then-Sen. Lyndon Johnson), churches and other nonprofit organizations that are exempt from taxation "are absolutely prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for elective public office," according to the IRS website. The beginning of a new Congress is a great opportunity for charities to get in on the ground floor and advocate for their causes.

Whether your organization seeks to protect something it cares about, bring about changes, or beef up legislation, nonprofits must build relationships with elected officials that are mutually beneficial.

"We know that it's not business as usual in Washington, D.C., this year," says Christopher Kush, author of *The One-Hour Activist* and CEO of Soapbox Consulting, which helps charities develop advocacy strategies. "To really be stewards of the issues we represent, we have to be sure we are actively working on protecting them and supporting them."

If your organization does not meet with policy makers, another organization will, says Mr. Kush. And as the saying goes, "If you're not at the table, you're on the menu." [Read more.](#)

Maximizing major gift fundraising

Though this blog focuses on major gifts, it is important to remember to approach conversations with donors and prospects holistically - integrating annual, planned, and major gifts into the discussions when appropriate based on the donors' needs.
