Data-mapping fellowships available

Applications are open for a three-month fellowship program that can provide nonprofits with GIS students to implement geospatial data analysis and visual projects this summer.

Azavea in Philadelphia, Pa., has offered its Summer of Maps for five years. The certified B-corporation provides "civic geospatial software and data analytics" for the web. Summer of Maps is a three-month fellowship giving student GIS analysts the opportunity to perform geospatial data analysis for local and national nonprofits with mentors.

Geospatial data analysis and visualization can mean different things to different nonprofits. For arts and culture organizations, it could mean analyzing geographic location of ticket sales and donations to identify existing clusters and untapped markets. For nonprofits in the realm of public safety, it could be analyzing the impact of neighborhood indicators or other factors on crime risk. For environmental nonprofits might analyze the urban tree canopy and existing development to make a recommendation for future preservation. [Read more.](#)



Thousands gather at Sonoma County Fairgrounds to show another world possible

While thousands of people protested at airports across the country Sunday against President Donald Trump's executive order barring people from several predominantly Muslim nations from entry into the United States, people crammed shoulder to shoulder into Garrett Hall at the Sonoma County Fairgrounds for a number of different reasons.

They signed up to volunteer for environmental groups, discuss politics with military veterans, write encouraging letters to refugees across the world, read about composting food and ask about affordable-housing advocacy programs.

"I want to fight the good fight right now," said Tanya Turneaure, a Sebastopol resident and middle school teacher, who watched her 16-year-old daughter write "we're thinking of you" on a note for people in Greek refugee camps.

Are EZ charities really easy? Yes ... and no

IRS recognition of a nonprofit's tax-exempt status is crucial for any nonprofit hoping to receive grants. Most grantors or donors need advanced assurance of the IRS determination of tax-exemption or deductibility to satisfy tax obligations upon them.

In 2014, the IRS introduced the Form 1023-EZ, designed to streamline the process for smaller nonprofits. However, some concerns arose regarding the ability of grantors to rely on EZ determination letters. The IRS has assuaged some of these concerns, but others remain. [Read more.](#)

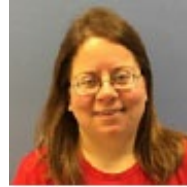

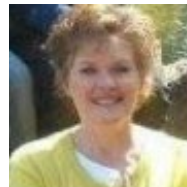

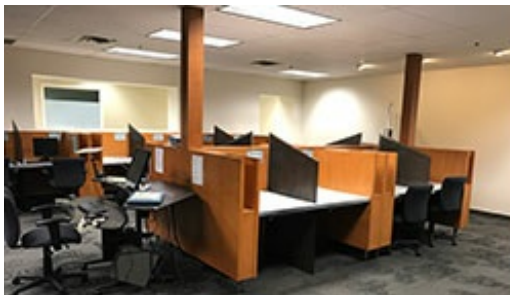
