Cheryl Taylor knows the effects of thoughtful, reflective grant giving. Since 2001, she's been president of the Fort Wayne-based Foellinger Foundation, whose mission since its founding in 1958 has been to strengthen organizations in Allen County that serve children and families, particularly those with the "greatest economic need and the least opportunity."



But, in 2007, the foundation wondered if it could do more than simply write checks to deserving organizations. What if it got really involved and partnered with these organizations to help them succeed?

The Foellinger board decided it was "interested in funding the most adaptive organizations, most effective organizations, the ones that focus on good governance, the ones that focus on good management, the ones that focus on results." [Read more.](#)



Nurturing nonprofit leadership

Leadership can be nurtured and cultivated. And in the past year, the Fort Wayne-based Foellinger Foundation has taken on that job.

Since 2008, the foundation has worked to strengthen nonprofits in the Fort Wayne area, but it hasn't stopped with its Invited-Initiative.

Last year, it launched the Foellinger Center for Nonprofit Adaptive Leadership, a program focused on developing leadership that is needed for today's nonprofits, leadership that can adapt to the changing economy and needs.

Has your organization set a New Year's resolution?

It's that time of year - time to set workout goals and lose those bad habits that the holidays helped create. We all know New Year's resolutions serve as a way to challenge us as individuals, but perhaps that should be extended into our organizations as we move into 2017. Let's explore three areas that are easy to bypass when running organizations on a day-to-day basis, but could be instrumental steps for success in 2017.

Setting donor goals

Many organizations utilize a fundraising budget that can be tracked with actual comparisons throughout the year. In order to help you meet these budgets, try setting targets in non-financial terms. For example, maybe you want to contact 25 corporations and 10 major donors in 2017. Consider breaking down specific categories into smaller groups. Instead of budgeting a dollar amount in grants, set a goal of 10 grant applications of less than \$10,000, 10 grant applications of \$10,000 to \$50,000, and so on. By examining your historical success rate and comparing it to your target number of asks, you'll have a better idea which formula may bring the most success. Could putting efforts into one larger grant bring you the same financial results as spending significant time on multiple smaller grants? [Read more.](#)
