## Agency-by-agency look at Trump's budget

Highlight: The budget would reduce spending National Forest land acquisition, rural water infrastructure and statistical capabilities at the department. It also proposes reduced staff in county USDA offices, an idea that fell flat in Congress when Barack Obama proposed a similar reduction.



The budget would eliminate the International Food for Education and Child Nutrition Program, which uses U.S. agricultural commodities and other financial assistance to support school feeding and child nutrition projects around the world, particularly for girls. The program aims to boost school enrollment, increase academic performance and improve children's health. It is named after former U.S. Sens. George McGovern, D-S.D., and Robert Dole, R-Kan., in recognition of their efforts to eradicate childhood hunger. [Read more.](#)



## Trump budget would cut programs for 20,000 Indiana kids

Local nonprofit leaders are raising their voices to speak for disadvantaged children in Indianapolis who they say would be hurt by federal budget cuts proposed by President Donald Trump's administration.

The 53-page budget summary released this past week is light on details, but proposes eliminating the 21st Century Community Learning Centers program, which serves 20,000 children in Indiana and 1.6 million children nationwide in before- and after-school programs.

It's part of a bigger push to cut federal education spending by \$9 billion, or 13.5 percent, in 2018. At the same time, funding for charter school and voucher programs would grow by \$1.4 billion nationwide. [Read more.](#)



## Could Trump's budget priorities threaten existing contracts?

Nonprofits receiving contract awards from New York City or the state should carefully monitor President Donald Trump's budget policies for potential retroactive effects on pre-existing contracts.

New York City Comptroller Scott Stringer recently reported that while just 9 percent of the city's budget is federally funded, city agencies that provide social services depend heavily on federal grants. The New York City Department of Housing Preservation and Development receives 48 percent of its budget from the federal government, the city Administration for Children's Services receives 43 percent and the city Department of Homeless Services gets 34 percent of its budget from the feds. ## Security 2017 update: Spotting and stopping hacking attempts day-to-day

Technology security is an ever-changing landscape, with new risks coming quickly and that are subtler. The three examples are from real situations that Netlink has helped clients with in the last six months. Our intention is that in sharing them, you will note the sophistication and follow our recommended precautions to keep your organization safe.

- Physical security risks: In 2016, an individual entered an apartment leasing office posing as a printer repair technician. The individual inserted a USB Flash Drive in several desktop computers. The office manager called our company and we investigated each computer, changing passwords, checking for malware and making sure each machine was secure. All the company's sensitive data was stored on an offsite main server, which couldn't be accessed by the USB Flash Drive.


