Charities could lose \$13 billion a year under Trump tax plan: They're fighting back

Charities have been bemoaning how President Donald Trump's tax plan could hurt giving and now they've put a hard and fast number on the potential damage: \$13 billion. That's how much charities could lose in gifts in just one year, according to a new study by Indiana University's Lilly Family School of Philanthropy. Charitable giving to religious organizations could drop by as much as 4.7 percent and giving to other types of charities could drop by as much as 4.4 percent.



This looming danger has led charities to reintroduce an old idea -- the above-the-line charitable income tax deduction -- that would be available to all taxpayers, regardless of whether they take itemized deductions. It was the law from 1982 to 1986, and it could be the answer to democratize charitable giving. Expanding the charitable deduction this way has the potential to more than offset the estimated loss in charitable dollars resulting from current tax reform proposals, according to the Indiana University study, Tax Policy And Charitable Giving Results. Government Accountability Office faults Education Department's oversight of grants

Each year, the U.S. Education Department distributes billions of dollars in grants to schools, districts, states and nonprofits, and the agency needs to do a better job making sure that it is adequately monitoring whether the money is achieving its intended goals, according to a Government Accountability Office report.

Many grants are doled out over multiple years, and grantees are supposed to show "substantial progress" toward their goals to receive their next installment of funds. The GAO found that in 2015, during the Obama administration, department employees did not consistently adhere to protocols for documenting their efforts to monitor grants, making it impossible for outside investigators to determine whether grantees made enough progress to get the money they received. Need for social services holds steady in 2016 as several states still struggle

The need for basic human services in the United States fell slightly in 2016, though pockets of high need persist in states around the country, according to new data.

The Human Needs Index, produced by the Indiana University Lilly Family School of Philanthropy using data from the Salvation Army, combines information about services provided to help people with groceries, prepared meals, clothing, housing, furniture, medical assistance, and energy bills into a single score.

"Although the news and the data certainly suggest that the economy is improving and people are back to work, poverty is still persistent," says Una Osili, director of research at the Lilly School. "There are areas of vulnerability; there are households that are still in need." [Read more.](#)

No cost employee benefit helps employees avert crisis

While nonprofits excel at providing work opportunities "that matter," their employees oftentimes sacrifice salary or additional perks available to those in the private sector.

Most of the time, the intangible rewards of work outweigh the downsides of working for an organization on a tight budget.

But when an unexpected hospital visit or a car repair bill hits, it can often snowball into a full-blown financial crisis. When faced with those expenses and, the lure of fast cash available at a payday loan store may become tempting.

But sadly, this short-term solution often extends far deeper into its users' pockets than originally promised. Because payday lenders encourage multiple renewals of loans -- leading to interest payments frequently many times greater than the original loan amount, the product is generally considered a debt trap. Nearly 76 percent of payday loans are quick re-borrows or renewals. [Read more.](#)
