In 2012, a staggering 46.5 million people were living in poverty in the United States -- the largest number in the 54 years the U.S. Census has measured poverty. This figure has increased or held steady for 11 of the past 12 years.

The reasons are varied, but one contributing factor resonates: Over the same period of time, incomes have stagnated or declined.

And with more people earning less, the need for human services has increased, while funding for these services has not.

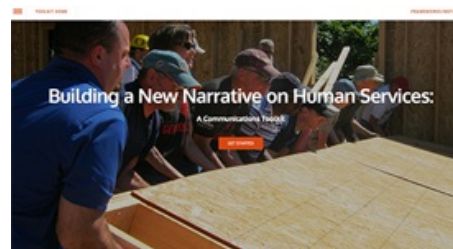



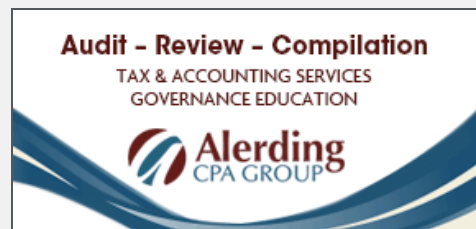
