## Report for America supports journalism where cutbacks hit hard

A group of journalists have decided to do something about the diminution of newsrooms at the local level. They're making reporting part of a national service program.

Report for America, a nonprofit organization modeled after AmeriCorps, aims to install 1,000 journalists in understaffed newsrooms by 2022. Now in its pilot stage, the initiative has placed three reporters in Appalachia. It has chosen nine more, from 740 applicants, to be deployed across the country in June.

Molly Born, 29, was one of the first three selected for the program. She grew up in West Virginia and has the state motto tattooed on her back: "Montani Semper Liberi" ("Mountaineers Are Always Free"). A reporter at *The Pittsburgh Post-Gazette* for the last six years, Ms. Born applied to Report for America with the hope of covering her home state.

"I felt like I needed to give something back to a place that has given a lot to me," she said. "And journalism is the way for me to do that." [Read more.](#)



## University presses are not in crisis

With the news that the University Press of New England will be shut down came the predictable takes on the plight of university press publishing today. But despite sensational headlines like the one this week in the Chronicle of Higher Education-"Scholarly Publishing's Last Stand"-university presses, by the numbers, are actually faring rather well.

According to the Association of American Publishers, university press sales through November 2017 (the latest audited numbers) are up 5 percent over the previous year-solid gains. And the near future looks bright: given the state of our political affairs, the market for good, trusted works is only expanding. With new

collaborations, marketing opportunities via social media, and supply chain innovations, regional publishing is more efficient than ever. And in categories like poetry, university presses are standard-bearers.

Association of University Presses executive director Peter Berkery stresses that despite the recent unfortunate situations regarding UPNE and the University Press of Kentucky, the reality for university press publishing is one of growth and innovation -- not crisis. AUP membership, in fact, is on the rise, he said.

## Sponsor's insight

### Stay vigilant and use due diligence when hiring outside service providers

Recently, I heard about a new form of theft against a central Indiana nonprofit. Using the organization's login information for its credit card processor, a perpetrator was able to issue repeated refunds to a Russian bank account. The first two - one for \$9,000 and the other for \$21,000 -- were processed. The business administrator, however, caught the third attempt for \$80,000, when he logged into the account and noticed the pending payment.



Fortunately, insurance refunded the \$30,000 that was stolen, but ultimately the nonprofit has the responsibility for selecting a qualified service provider. With that in mind, organizations should exercise caution when using credit card processors, donation websites, and any other outside service providers that involve financial information.

In another example involving donations received from individuals, a class action lawsuit was filed against Paypal in 2015 related to its "Giving Fund" platform. The lawsuit was filed by nonprofits listed on the Giving Fund platform that didn't receive their intended donations. Paypal reportedly redirected donations intended for specific charities to other organizations of their own choosing. In 2017, Paypal was ordered to establish a \$4 million settlement fund. In this case, the nonprofits may not have known ahead of time that their


