## What barbershops can teach about delivering health care

Heart disease is the most common killer of men in the United States, and high blood pressure is one of the greatest risk factors for heart disease. Despite knowing this for some time, we have had a hard time getting patients to comply with recommendations and medications.

A recent study shows that the means of communication may be as important as the message itself, maybe even more so. Also, it suggests that health care need not take place in a doctor's office - or be provided by a physician - to be effective.



It might, as in this study, take place in a barbershop, an institution that has long played a significant social, economic and cultural role in African-American life. A setting that fosters both confidentiality and camaraderie seems like a good place to try reaching men to talk about hypertension.

## Ten reasons not to measure impact — and what to do instead

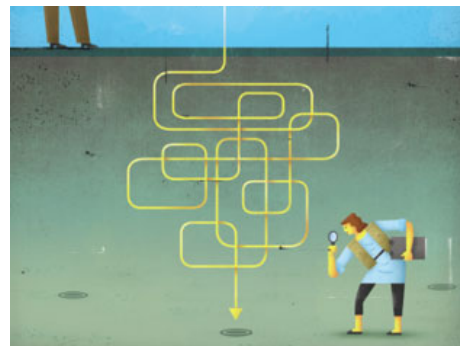
Would you rather help one child a little bit today, or wait a few years and help five children even more? Every dollar spent on current programs is a dollar used to help today's children in need -- a worthy cause. Yet every dollar spent on research today, in theory, is a dollar invested in helping tomorrow's children even more. Admittedly, this trade-off is complex, imprecise, and uncertain. But the promise of research that can help us do more good per dollar spent is enticing.



Yet here's one cautionary claim we can make for certain: Every dollar

spent on poorly conceived research that does not help tomorrow's children is a dollar wasted.

Good impact evaluations -- those that answer policy-relevant questions with rigor -- have improved development knowledge, policy, and practice. For example, the NGO Living Goods conducted a rigorous evaluation to measure the impact of its community health model based on door-to-door sales and promotions. The evidence of impact was strong: Their model generated a 27-percent reduction in child mortality. This evidence subsequently persuaded policy makers, replication partners, and major funders to support the rapid expansion of Living Goods' reach to five million people. Meanwhile, rigorous evidence continues to further validate the model and help to make it work even better.



Of course, not all rigorous research offers such quick and rosy results. Consider the many studies required to discover a successful drug and the lengthy process of seeking regulatory approval and adoption by the healthcare system. The same holds true for fighting poverty.

## The art of major gift fundraising

For Angela Gill, sharing the joy of giving is one of the best parts of her job as Executive Director of the Major Hospital Foundation in Shelbyville.

That's a good thing, because the health-care system her foundation serves is expanding. In the past few years, it has opened a new hospital and health campus and partnered with Veteran Health Indiana to open a new veterans' clinic. And this year, it will begin building a new nephrology center to focus on kidney health, thanks to a donor's generosity.

Gill is aided in helping donors find the joy in giving by her extensive professional experience -- including holding key roles at the Blue River Community Foundation and Shelby County United Fund before joining the Major Hospital Foundation in 2006 -- and her graduate education. She earned her master's degree in philanthropic studies from the Indiana University Lilly Family School of Philanthropy at IUPUI in 2011.

Since graduating, Gill has applied that knowledge, including an understanding of the art of fundraising, to her work. Recently, the foundation was awarded a major gift from a generous donor to build a freestanding nephrology center. Gill spoke about the process of securing this gift - a years-long process that began with a small gift from an interested individual

## CHIEF EXECUTIVE DOs & DON'Ts in Recruiting Nonprofit Board Members

### DO

Develop networks of friends and organizations that share similar values and use those networks to identify potential board members.

Recommend qualified individuals to serve on the board by outlining to the nominating committee what the person would bring to the table.

Suggest that potential board members serve on a committee before being elected to the full board.

### DON'T

Recommend for possible board members individuals with whom the chief executive would like to enhance a personal relationship.

Fail to disclose a previous relationship with a potential board member.

Leave the selection of new board members to chance by not participating fully in the recruitment and selection process.
