# Trump promised to destroy the Johnson Amendment. Congress is targeting it now.

Lawmakers appear to be using a new spending bill to target a 1950s law that effectively bars nonprofits like churches from endorsing or opposing political candidates.

Many pastors already ignore the so-called Johnson Amendment, and the IRS rarely investigates churches that violate a law that many clergy feel provides a chilling effect on their free speech. But some observers fear the language proposed in a new spending bill released this week would make it difficult for the IRS to investigate any claims of pulpit politicking or money flowing between houses of worship and political campaigns.



During his campaign for the presidency, Donald Trump targeted the Johnson Amendment as a big part of his pitch to religious conservatives, but because the amendment is law, repealing it would take an act of Congress. [Read more.](#)



## Trump claims he got rid of the Johnson Amendment. Is that true?

Responding to compliments about his election victory and support from evangelical voters, President Donald Trump told Christian Broadcasting Network's founder Pat Robertson that he had signed an order to empower religious leaders to speak up politically.

"We've really helped because I've gotten rid of the Johnson Amendment, now we are going to go try to get rid of it permanently in Congress, but I signed an executive order so that now people like you that I want to hear from, ministers and preachers and rabbis and whoever it may be, they can speak," Trump said in a July 12 interview with Robertson. "You know, you couldn't speak politically before; now you can. And I want to hear from you and others that we like."

During the campaign Trump accurately said that an amendment pushed by Lyndon B. Johnson threatened religious institutions with the loss of their tax-exempt status if they openly advocated their political views. Trump then said he would repeal that language. [Read more.](#)



## The Library of Congress opened its catalogs to the world. Here's why it matters

Imagine you wanted to find books or journal articles on a particular subject. Or find manuscripts by a particular author. Or locate serials, music or maps. You would use a library catalog that includes facts -- like title, author, publication date, subject headings and genre.

That information and more is stored in the treasure trove of library catalogs.

It is hard to overstate how important this library catalog information is, particularly as the amount of information expands every day. With this information, scholars and librarians are able to find things in a predictable way. That's because of the descriptive facts presented in a systematic way in catalog records.

But what if you could also experiment with the data in those records to explore other kinds of research questions -- like trends in subject matter, semantics in titles or patterns in the geographic source of works on a given topic? [Read more.](#)

## The need for more basic philanthropy research

Judging by the proliferation of research-inspired ventures, it may seem we're in a golden age of philanthropic knowledge creation. But we are not focusing enough of our efforts on basic research.

Given the urgency of finding better ways to solve pressing social issues, it's not surprising that the vast majority of research generated is applied research. Both the standard ways of doing philanthropy and the paradigm-bending (and busting) efforts to transform and disrupt conventional approaches come armed with research findings on what works, where there are strategic gaps in expectations and how some interventions are more effective than others.

This data-driven search for solutions is awesome and inspiring. Our current philanthropic research ecosystem is highly fragmented. Its inhabitants often belong to a variety of industries or professions whose connection to philanthropy is contingent on other interests and commitments. And today's growing expectations of philanthropy are only likely to increase because of current political winds, and because total annual giving at \$390 billion does not seem small compared to the nonmilitary portion of federal discretionary spending: \$518 billion a year.
