## Ford Foundation is an unlikely convert to 'impact' investing

Peter A. Nadosy is a pillar of the Wall Street establishment -- he spent 27 years at Morgan Stanley, rising to vice chairman. He served a stint managing the endowment at Harvard, his alma mater, and he's also a life trustee and member of the investment committee at Amherst College. He's on multiple boards of nonprofit institutions, including the Doris Duke Charitable Foundation and St. Andrew's Dune Church in Southampton, N.Y.



He is, in short, about the last person you'd expect to throw his support behind an investment strategy that makes fossil-fuel divestment -- something Mr. Nadosy opposes -- look tame by comparison. Yet, as chairman of the Ford Foundation's investment committee, which oversees the foundation's \$12 billion-plus endowment, he's now in the vanguard of an approach to endowment management that breaks with generations of investment orthodoxy.

Last week, the foundation announced that it would commit \$1 billion to investments that "earn not only attractive financial returns but concrete social returns as well," as it said in a news release. Read more.



# Governing a collaborative organization

It's easy to say that organizations should be collaborative, but what does that actually mean? And what does it take from executives and board members to actually make it happen?

In their articles The Networked Nonprofit and The Most Impactful Leaders You've Never Heard Of, Jane Wei-Skillern and her colleagues present a persuasive case for a form of collaborative leadership that becomes possible only when we let go of the desire -- or need -- to do everything on our own, and invest in new opportunities to lead in collaboration with others. They describe four leadership characteristics: trust, not control; humility, not brand; node, not hub; and mission, not organization.

These concepts echo the idea of "network mind-set," an orientation to collaboration that Forces for Good authors Leslie Crutchfield and Heather McLeod Grant found in each of the 12 high-impact nonprofits they studied.

While both of these leadership frameworks are compelling, I'm struck by the fact that there's very little discussion about what such approaches require from boards. Perhaps the assumption is that they don't require anything different. But if we're arguing for a different type of organizational orientation and a



## Georgia nonprofit says it unwittingly gave \$25,000 to white nationalist Richard Spencer

The largest donor to Richard Spencer's nonprofit in recent years was a Georgia community foundation that said it didn't know it was supporting a white nationalist.

Its donations to his National Policy Institute totaled \$25,000 from 2013 to 2014, according to three years of unpublished tax returns that Spencer gave to The Times.

The returns offer the most detailed look to date at the finances of a white nationalist who has risen to national prominence over the last year. The growing revenue of his organization - which has failed to file tax returns with the Internal Revenue Service since 2012 and as a result lost its tax-exempt status — came primarily from anonymous donors and conferences advocating a separate nation for white people.

The Georgia group, the Community Foundation for the Central Savannah River Area, which promotes philanthropy to a wide range of causes and counts the Masters golf tournament as one of its biggest donors, is based in Augusta and gives away between \$5 million to \$9 million a year. Read more.

## **Grantwriting: Today's funders consider themselves investors**

Investors don't want to invest in services. They want to invest in change. They are looking for organizations that have moved from reporting about activities to reporting about outcomes or results.

The measure shifts from what the agency did to what the clients did or what client behavior was changed as a result of working with the agency. And, was the change in client behavior enduring?

For example, instead of simply reporting family caseload numbers, some preventive agencies now focus on results: families where foster care was averted or number of parents who stayed drug free for six months or more. Did a father enrolled in a parenting class maintain a positive relationship with his child's mother for six months to a year? Did more fathers start paying child support, allowing taxpayers to save on welfare costs? Read more.

#### A board member's time

I am 15 minutes into a nonprofit board meeting and I look around the table to take note of the talent represented -- diverse, busy, expensive talent. Wondering how much each person charges for an hour of his or her time, I add up \$150, \$250, \$95, \$300, circling the table for a total guesstimate of \$2000.

Huh, I wonder whether our organization would have paid \$500 for the last 15 minutes of getting everyone up to speed?

In that moment, the concept of best use of a board member's limited time and great talent crystallized for me.

Fast forward a year. Different job, working with a different board. I'm on the phone with Christy Kim. She is the 2017 Board President for the Raleigh-Wake Human Resource Management Association (RWHRMA) in North Carolina.

"Our board position terms are officially one year, so to be effective we need a place to be organized and a platform to help keep our meetings strategic. We need something to make handoffs easier from one board officer to the next." Kim tells me over the phone. "And we need a tool to fit the working methods and technical abilities of different generations -- Millennials, Gen-Xers, and Boomers."

I'm talking with Kim because I now work for Boardable, an Indianapolis-based startup that is building board management software. It is software that is cloud-based, so it can be used on any computer or device, and born in the heyday of user-experience (UX) design, so it's intuitive to use. No need for an IT office or specially-trained administrator. Read more.


**Camptown** was selected to receive a \$3,000 Finish Line Youth Foundation Grant that will help support its Natural Wonders Day summer camp program.




