The future MD telling stories for social change

When 21-year-old Christine Chen, founder of online platform DiverseCity and a 2016 OZY Genius Award recipient, traverses San Francisco's Bay Area on bike - lugging her tripod, backpack and camera bag - to meet up with a subject for her video project, she's usually listening to a podcast. A self-proclaimed multimedia junkie, she counts This American Life and Beautiful Stories from Anonymous People among her favorites. As she mulls over each spoken word, she creates anagrams in her mind. El Camino Real rearranges to "alien clam roe," she explains. The letters in her name,



Christine, can be re-sorted to "nice shirt." She delights in arriving at unexpected words with completely different meanings.

When Chen, a Stanford senior studying human biology, received a grant from OZY last year, she dove further into developing DiverseCity, which illuminates the career paths of a diverse group of leaders in order to inspire low-income, minority students to think ambitiously about their careers. Intrigued by the influence of TED Talks, which published more than 2,100 video presentations that have been viewed more than a billion times, Chen started out by asking professionals to upload videos about their careers and the challenges they overcame. Since receiving the grant, Chen has met many of these

leaders in person, interviewing them for up to four hour-long stretches before editing and sharing their stories online. <u>Read more.</u>

Are nonprofits getting in the way of social change?

Almost a billion people go to bed hungry every night yet the World Food Program believes that the existing knowledge, tools, and policies, combined with political will, can solve this problem. In 2008, Cornell's academic staff identified sufficient education in science, critical thinking, and environmental issues; the epidemic of preventable illnesses in the third world; inequitable access to health care; and the shortage of potable and clean water as some the world's most important problems that are also most easily solved.

While many important socio-economic and environmental problems remain intractable, a combination of increased awareness, new technology, adequate funding, and more collaboration among corporations, civil society, and governments has created a context where effective social change is possible.

The evidence that meaningful change is within our reach is galvanizing changemakers in all sectors. It is also causing us to have very different expectations of nonprofits -- the groups that we have seen until recently as the primary catalysts for social change. <u>Read more.</u>



100,000 Poets for Change use the power of words to push social change

How to protect your organization from cybercriminals

You are sitting at your computer, working happily away on a project, when you receive an email from a co-worker or friend, encouraging you to open an embedded link or an attachment. Or maybe it's an urgently worded email from your organization's executive director, instructing you to

immediately wire funds to a new vendor. Or worse, the message instructs you to email to them the W-2 information of all your employees. Curious or eager to help, you click on the link or open the attachment.

Unfortunately, you've just exposed your organization to <u>Business Email Compromise</u> and the potential loss of confidential information, as well as funds.

In recent months in Indiana, nonprofits, governmental entities and private corporations have all been targeted by cybercriminals who gained access to information, mostly through emails containing embedded links or attachments. Cybercriminals threaten to steal your data, encrypt or destroy it or make confidential records public. If you're "lucky," they may offer to give the data back...for a price. Read more.


