# 10 workplace trends in 2018

All economic indicators show a positive view of the U.S. economy in 2018. The Bureau of Labor Statistics predicts that the unemployment rate will continue to decline from 4.3 percent in 2017 to 4.2 percent in 2017, with an overall projection of 20.5 million jobs being created by 2020. While the majority of occupations are projected to grow, those that will experience the fastest growth next year are healthcare, personal care, social assistance and construction. The workforce participation of older workers will increase, yet the overall labor force growth rate will decline by next year.



U.S. salaries are predicted to increase from 3.1 percent in 2017 to 3.2 percent in 2018. Gross domestic product is expected to increase from 2.3 percent in 2017 to 2.5 percent in 2018. The top workplace trends for 2018 include:

1. Leaders encourage more human interaction. Companies will continue to promote their workspaces and design them to facilitate interpersonal relationships between employees. IBM stopped their remote-working program, pushing thousands of employees from core groups that support their brands back to the office. Apple's innovative new facility is designed to promote worker relationships, idea sharing and collaboration. Google Caf s are designed to encourage interactions between employees across departments and teams. Read more.

# The rise and fall of working from home


Last year, Richard Laermer decided to let his employees work from home on a regular basis. "We hire adults, they shouldn't be tied to the office five days a week," said Laermer, who owns a New York-based public relations firm. "I always assumed that you can get your work done anywhere, as long as you actually get it done."

Turns out, he was wrong.

Employees took advantage of the perk, Laermer said. One was unavailable for hours at a time. Another wouldn't communicate with co-workers all day, which Laermer found suspicious. The last straw, he said, was when someone refused to come in for a meeting because she had plans to go to the Hamptons. "That was the most unbelievably nervy thing I'd heard in years," he said.

Ten months in, he scrapped the benefit and now requires all of his employees to come into the office every day.

# Do telecommuting and flexible work arrangements right

Flexible hours and working from home are benefits that many nonprofits want to implement, but are not sure how to do it fairly and in a way that acknowledges the value of having people in the office together.

Working from home and other alternative work arrangements are desirable for several reasons: flexible hours can help employees and their families; telecommuting can save time and expense and natural resources, and customized arrangements can help retain valuable employees.

But it's also hard to manage such flexibility fairly and balance it with the benefits of proximity in mind. At Save the Bay, with a modest office workforce of 26, we knew we couldn't afford to universally approve every request, so we devised a process for evaluating requests.

# Attracting and retaining good fundraising talent

The foundation of a strong fundraising program is built on relationships. When your organization has a talented and dedicated staff, you have the key elements to form relationships with your donors.

What can you do to ensure you're attracting and retaining your most valuable asset - people - while growing a strong culture of philanthropy?

#### What does the data show us about the current landscape of hiring development staff?

Recent research shows that the fundraising profession has a high turnover in staff positions and a dearth of qualified candidates to fill the void. Working with our clients, we hear stories of vacancies, long searches and short stays.

Here are some basic facts:

- The average tenure for major gift officer positions is 18 to 24 months, according to a study by the Education Advisory Board.
- According to the Underdeveloped Study, development director positions are also in a high state of turnover, with 50 percent of development directors indicating they anticipate leaving their position in the next two years and anywhere from 11 to 27 percent -depending on organization size -- saying they anticipate leaving the field of development all together.
- The same study found that more than half (53 percent) of executive directors reported that
  their most recent development director hiring process attracted an insufficient number of
  candidates with the right mix of skills and experience.




