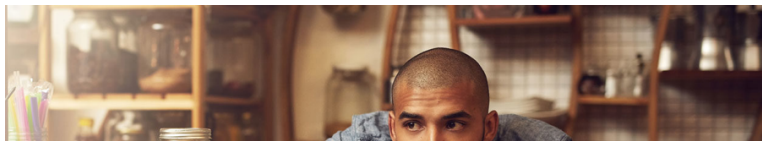

## New study shows minimum wage puts damper on long-run earnings

Economic studies consistently show that higher minimum wages lead to higher unemployment, particularly among teenagers.



But that's a consequence minimum wage advocates have been willing to accept in exchange for higher incomes for minimum wage workers who keep their jobs.



It turns out, however, that higher minimum wages actually reduced the long-run earnings of teenagers who were exposed to the higher minimum wages.

That's according to a new study from the Mercatus Center, a nonprofit free market-oriented think tank, which examined the steep decline in teenage employment over the past two decades and, in particular, whether that decline in employment led to higher or lower human capital -- in other words, workers' knowledge and skills -- and earnings.

Between 1994 and 2014, labor force participation among 16- to 19-year-olds fell from 53 percent to 34 percent. That's a huge decline over a relatively short period of time. [Read more.](#)

## Setting young people on a path to Lifelong Success

The access and opportunities that help many of us get ahead in life are not equally available to those living in under-resourced communities. Structural racial, ethnic, gender, and economic inequities in these communities often stand in the way of the dream of business ownership, and the independence and self-reliance that can come with being entrepreneurial.

Some strides have been made to encourage inclusive entrepreneurship programs for women and people of color, as noted in an August 2016 Stanford Social Innovation Review article, "A Call for Inclusive Entrepreneurship." The nonprofit Rising Tide Capital, for example, provides a range of business development services -- including management education, networking, mentorship, sales opportunities, and access to capital -- to help individuals in economically struggling Northern New Jersey communities start and grow successful businesses.

While the organization has seen strong business survival rates and local job creation, these positive results do not extend to young people still in school. And yet the foundation of any inclusive entrepreneurial environment must include pathways for young people to explore entrepreneurship and learn that being entrepreneurial can become part of their future. ## Teens 'desperate to work' drive surge in Baltimore YouthWorks jobs program

Baltimore's YouthWorks program -- which connects teenagers to summer jobs -- is experiencing a boom this year with more than 16,000 young people applying to seek employment.

That's a 40 percent increase from just two years ago, according to the city.

"The applications are really high and up," said Mayor Catherine E. Pugh, who highlighted the growth in summer job applications during her annual state-of-the-city speech this week. "It bodes well for the future of Baltimore."

Since its inception in the mid-1990s, YouthWorks had typically employed about 5,000 people each summer. But that number jumped after the civil unrest of 2015, which sparked more interest from businesses. The program has served more than 8,000 youths the past two summers. [Read more.](#)

## Fiscal sponsorships: Get the benefits of a charity without being one

Many people know that charities can be tax-exempt from many forms of taxation and that their donors commonly receive tax benefits for their donations to the organization. Charities also receive the benefit of a formal structure that puts the organization's mission and interests above the personal interests of those involved. This proper corporate or trust structure provides the Directors, Officers, and/or Trustees of the charity protection from liability.

But forming a nonprofit organization also comes with its share of added responsibilities and costs as well. These include administrative costs, various governmental filings, an increase in the information available to the public, as well as a potential lengthy delay in obtaining IRS recognition of tax-exempt status that can be as long as nine months once the application is submitted. In some cases, it might be possible for a charity to start operations faster by entering into what is called a fiscal sponsorship.

A fiscal sponsorship can provide a place for the charity to grow and thrive without all of the added responsibilities that come with forming and operating a nonprofit organization, at least until it is ready for the charity to operate on its own, if the charity so desires. [Read more.](#)
