Who owned the donor list?

House committee report outlines Greitens' use, misuse of The Mission Continues donor list

Eric Greitens was a former Navy SEAL when he helped found The Mission Continues (TMC) in 2007 to help returning veterans find a purpose after their service -- and during his 2016 campaign for governor, he often talked about the success stories the charity helped create.

Today, that charity is caught in the middle of legislative and criminal investigations focused on Greitens' role with The Mission Continues and accusations he took information from the charity to help with his political campaign.



Last week, when the Missouri House Special Investigative Committee on Oversight released its report about the governor and the charity, Chairman Jay Barnes, R-Jefferson City, said: "The report shows the governor took advantage of a charity that works hard to take care of our veterans. The committee found that the Mission Continues was the true owner of the fundraising list and its property was taken without permission and used inappropriately for political gain." [Read more.](#)

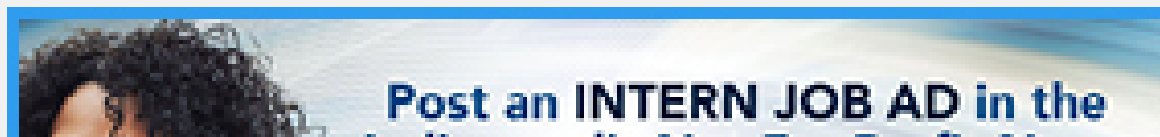

BOARD CHAIR PREP

Are you about to become your organization's board chair? Here are eight things you need to do now to prepare for this key role.

1. REVIEW THE JOB DESCRIPTION

As the senior volunteer leader of the organization, the board chair is responsible for leading the board in the oversight and support responsibilities that are critical to good governance. The chair must be knowledgeable about the organization — its mission, vision, values, programs, services, constituents, and resources — and understand its place in the larger framework of the community and the not-for-profit sphere of local and national peer organizations. The chair's role is usually defined in the bylaws, but a separate job description should outline the duties in more detail. See sample on page 2.

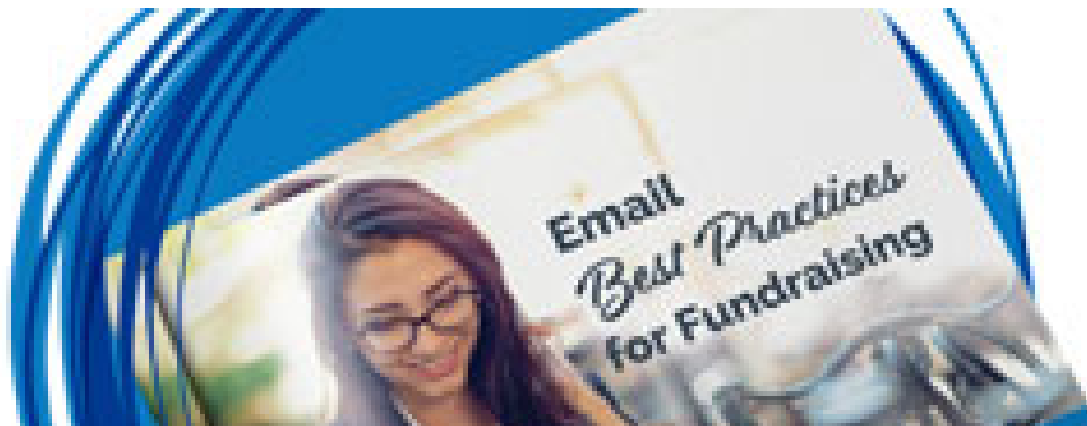
2. CARVE OUT TIME IN YOUR PERSONAL SCHEDULE

As you undoubtedly know, being the board chair is a considerable time commitment. It should not consume your life, however. Be cognizant of how much time you can commit to the organization and then achieve and maintain a balance.

3. CONSIDER CREATING A TIMETABLE TO ORGANIZE THE TIME YOU DEVOTE TO THE POSITION

Having a timetable will help you maximize your time and it creates the awareness of tasks and responsibilities. The timetable
